1. Appointment as Scrutinizer:

I, Dilip Kumar Sarawagi, Practicing Company Secretary, was appointed as the Scrutinizer for the remote e-voting as well as the poll conducted at the 29th Annual General Meeting ("29th AGM") of **Himalaya Granites Limited** (hereinafter referred to as "the Company") held on Monday, 25th September, 2017 at 10:00 A.M. at the Registered Office of the Company situated at Panchalam Village, Melpettai Post, Tindivanam, Tamil Nadu – 604 307.

2. Responsibility of Ensuring Compliance:

The Management of the Company assumes complete responsibility of ensuring compliance of Sections 108 and 109 of the Companies Act, 2013 read with Rules 20 and 21 of the Companies (Management and Administration) Rules, 2014 as may be necessary and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to remote e-voting and poll process.

3. <u>Dispatch of Notice Convening the 29th AGM:</u>

The Company has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the depositories viz., Central Depository Services (India) Limited (CDSL) and National Securities Depository Limited (NSDL), the Company completed dispatch of the Notice of the 29th AGM as under:-

- On 1st September, 2017 by e-mail to 363 members who had registered their e-mail ids with the Company / Depositories.
- On 1st September, 2017 by Post / Registered Post/ Courier to 776 members in physical form who had not registered their e-mail ids with the Company / Depositories.

4. Cut-Off Date:

The voting rights were reckoned as on Monday, 18th September, 2017 being the cut-off date for the purpose of deciding the entitlements of members for the remote e-voting and voting at the 29th AGM.



Remote E-Voting:

5.1. Agency:

The Company had appointed Central Depository Services (India) Limited (CDSL) as the agency for providing the remote e-voting platform.

5.2. Remote e-voting:

Remote e-voting platform was open from 10:00 A.M. (IST) on Friday, 22nd September, 2017 till 5:00 P.M. (IST) on Sunday, 24th September, 2017. During this period, Members of the Company holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. 18th September, 2017, were given the facility to cast their votes electronically conveying their assent or dissent in respect of the Resolutions set out in the notice of the 29th AGM.

6. Poll:

- 6.1 As prescribed under Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015, for the purpose of ensuring that Members who have cast their votes through remote e-voting do not vote again at the 29th AGM, the Scrutinizer shall have access after closure of period of remote e-voting and before the start of 29th AGM, to only such details relating to Members who have cast their votes through remote e-voting such as their names, DP Id / Client Id, Folios and number of shares held but not the manner in which they have cast their votes.
- **6.2** Accordingly, CDSL has provided us with the names, DP Id / Client Id, Folios and shareholding of the Members who had cast their votes through remote e-voting.
- **6.3** Considering the aforesaid, the Company issued poll papers only to those Members who attended the meeting but did-not cast vote through remote e-voting.

- **7.2** The votes were reconciled with the records maintained by the Company and / or RTA with respect to the authorizations and / or proxies lodged with the Company.
- 7.3 I unblocked the remote e-voting results on the CDSL e-voting platform in the presence of Ms. Daisy Kumari and Ms. Namrata Kumari Singh and downloaded the e-voting results.



8. Results:
